Mr. LAU Yu Leung, Chairman and Executive Director of Ever Harvest said, “Ever Harvest has worked hard in the past more than 20 years since it was founded in 1993 and is today among the five largest foreign trade transshipment service providers and the second largest among non-state owned service providers in Guangzhou, Shenzhen and Hong Kong.
